Guidelines & Nomination Form

Candidate Nominees must qualify for one of the following areas:

Category One – Teachers and/or Administrators*

Category Two – Support Personnel*

*Category Three** – School Supporters*

- ★ The RCS Hall-of-Fame Selection Committee will select no more than five and no fewer than two nominees each year for induction.
- ★ The RCSEF Board of Directors shall host an induction event in the spring of each year. Honorees or honorees' families will receive a plaque and an induction certificate. Honorees will be recognized in a designated Hall-of-Fame area at the Rutherford County Schools Administrative Building.
- ★ *Category One and Two nominees must have served Rutherford County Schools for at least 15 years. Consideration will be allowed if the nominee died in service to Rutherford County Schools or if disability prevented continued service by the nominee.
- ★ **Category Three nominees must have supported Rutherford County Schools and its greater good. These nominees must have made significant contributions of time, ideas, expertise or finances to the advancement of programs such as academics, arts, or extra curricular activities. The contributions should have had a lasting impact on the overall growth and health of the schools and learning environment.
